### **Guarantees and Conditions**

- 1. Buyer understands and seller has explained that the above Goldendoodle is being sold as a pet and not for breeding purposes.**
- 2. The seller agrees to furnish the buyer with written health information at the time of sale. This will include all immunization and worming records and further guarantees the Goldendoodle to be in good health and free of contagious diseases at the time it leaves Seller's possession for delivery to the buyer. The buyer is encouraged to take the dog to a veterinarian of his/her choice for a complete physical examination.**

3. Buyer will abide by all state and local laws regarding the licensing, leashing and other ordinances regarding pet ownership.
4. Buyer agrees to provide said Goldendoodle with annual veterinary checkups including heartworm preventatives; to provide proper nutrition, water and indoor housing; and when exercising, to confine the dog in an enclosed area to prevent loss or injury or to walk on a leash, and never to keep the dog on a chain or in a situation that would be detrimental to said dogs health or welfare. Non-compliance with any of these provisions will constitute abuse and the result is the seller-reclaiming dog without reimbursement to the buyer.
5. Buyer agrees to notify the seller of any significant health problems encountered that might be of a genetic/hereditary origin.
6. Buyers' purpose for purchasing above Goldendoodle is for companionship/pet only and not for conformation showing. Therefore the buyer is strongly encouraged to have this dog altered (spayed or neutered) between six and seven months of age. Spaying or neutering your pet will stop many future problems for you and may give your pet a longer healthier life.
7. Seller guarantees said Goldendoodle to be of sound temperament that is neither so shy nor vicious as to render the dog an unfit companion on the date of sale.
8. Your puppy will not be allowed to leave until 8 weeks of age. A one-year health guarantee against any life threatening genetic disorders is included.

*Special Provisions of Sale*

This contract shall be governed by the laws of the state of South Carolina to the exclusion of any other forum and constitutes the entire agreement between the parties. Deposit refunded if there is no puppy of the sex selected above.
